







STATUS: Received Board approval in September 2022; Construction begins in 2024. Expected completion in 2027.

BACKGROUND: Airside D was originally scheduled to begin the design phase in 2021; was delayed due to COVID.



Airside D Look Ahead

- May 2023: Board selected Design Builder- Hensel Phelps
- August 2023:
 - Board award Part 1 Design Contract
 - Start design
- Late 2024: Start enabling work construction
- Late 2027: Complete construction
- Early 2028: Complete move-in and airline relocations
